The effectiveness of the offer is subject to the condition that admission to trading is authorized by DDT before the Issue Date. MPS Capital Services Banca per le Imprese S.p.A. (“MPSCS”) undertakes to apply for the Securities to be admitted to trading on the Issue Date on the systematic internalization system (“SIS”) denominated “De@IDone Trading” (“DDT”), exclusively managed by MPSCS. . (the “**Distributor**”) are, with respect to the offer of the Securities, in a position of conflict of interest with the investors as they are part of the same banking group (the Montepaschi Banking Group) and they have an economic interest in the distribution of the Securities. MPSCS and the Distributor shall receive from the Issuer, respectively, the management fee and the selling fee, as specified under paragraph 8.2 (m) below.

MPSCS is also in a position of conflict of interest for the following reasons: it acts as hedging counterparty of the Issuer in relation to the issuance of the Securities; and it shall act as liquidity provider, providing bid/ask quotes for the Securities for the benefit of the holder of the Securities. Also, an application shall be made for the Securities to be admitted to trading on the systematic internalization system (“**SIS**”) denominated “De@lDone Trading” (“**DDT**”), exclusively managed by MPSCS on which MPSCS acts as sole manager (*negoziatore unico*).
