("**BMPS**" or the "**Issuer**") and guaranteed by MPS Covered Bond S.r.l. (the "**Guarantor**").

Capitalised terms used in this Supplement, and not otherwise defined herein, shall have the same meaning ascribed to them in the Prospectus.

This Supplement is supplemental to, and should be read in conjunction with, the Prospectus.

The purpose of the submission of this Supplement is to incorporate by reference in the Prospectus the press release relating to the Issuer's quarterly financial data as at 30 September 2015.

The Issuer accepts responsibility for the information contained in this Supplement.
