The Issuer, Goldman Sachs International, MPS Capital Services Banca per le Imprese S.p.A., in its capacity as lead manager (the "**Lead Manager**"), and Banca Monte Dei Paschi di Siena S.p.A., in its capacity as distributor (the "**Distributor**"), in the context of the public offer of the Notes carried out via final terms No. F-747 (the "**Final Terms**") inform the potential subscribers that:

- (i) pursuant to Articles 8 and 16 of the Directive 2003/71/EC (the "**Prospectus Directive**"), the Issuer published a supplement to the Base Prospectus on 19 September 2017 (the "**Supplement**") in compliance with the relevant provisions of the Prospectus Directive; and
- (ii) Pursuant to Article 16, paragraph 2, of the Prospectus Directive and Article 95-*bis*, second paragraph, of Legislative Decree No. 58 of 24 February 1998, investors who had already agreed to subscribe for the Notes before the Supplement was published shall have the right to withdraw their acceptances until and including 22 September 2017 by way of a written notice to be sent to the Distributor at the same address of the Distributor as indicated in the related subscription request.
